This has reference to your application I.D. 2. An Expert Team conducted onsite evaluation of the programs from 8<sup>th</sup> to 10<sup>th</sup> November, 2024. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The Institution has been conferred autonomous status for a period of ten years from the Academic Year 2020-21. Therefore, Noida Institute of Engineering & Technology, 19, Knowledge Park-II, Institutional Area, Greater Noida-201 306, Uttar Pradesh should submit fresh online application through eNBA portal in respect of above UG Engineering programs under Tier I Document not before five months from the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Noida Institute of Engineering & Technology, 19, Knowledge Park-II, Institutional Area, Greater Noida-201 306, Uttar Pradesh** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.

7. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
